Footscray Primary School is looking forward to another great year of teaching and learning and would like to advise you of Footscray Primary School's voluntary financial contributions for 2026.

Schools provide students with free instruction to fulfil the standard curriculum requirements and we want to assure you that all contributions are voluntary. Nevertheless, the ongoing financial support of our families ensures that we can continue to offer the best possible education experience for every child at Footscray Primary School.

Within our school this support has allowed us to organise and coordinate rich, extensive programs outside of the traditional teaching and learning programs. Our specialist programs of Art, Music, Science & Design, and PE are strengthened by your financial contributions, allowing us to purchase varied art resources, musical instruments, science and construction materials.

Additional programs we can offer because of your contributions include choir, productions and concerts, art shows, school and community events such as Book Week, Science Week, Market Day, 100 Days of School, sports events, and wellbeing programs such as SWPBS, engagement groups, and the Friendship Zone.

We make strategic use of our department funding to establish program budgets for areas such as Literacy, Numeracy, Wellbeing, ICT, Transitions, Professional Development, Intervention and many more. We also use our funding to subsidise the cost of curriculum materials that are not covered by voluntary contributions. In 2025, we received parent payments from 61% of our Foundation families, 49% of our Year 1-2 families, 45% of our Year 3-4 families and 40% of our Year 5-6 families. We drew on program budgets to subsidise the remaining costs to deliver the programs that we all believe are essential to meet the learning and wellbeing needs of our young people and the staff who support them.

To ensure we can continue to deliver on the high expectations held by all of us at Footscray Primary School we would really value your contributions in line with the Department's Parent Payments Policy.




### **FREE INSTRUCTION**

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.

## **PARENT PAYMENT REQUESTS**

Schools can request contributions from parents under three categories:





Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

# Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

# Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

• Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).

#### FINANCIAL HELP FOR FAMILIES



- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



#### SCHOOL PROCESSES
